

Global Go Green Giveaway – Score Prediction Contest

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT IMPROVE CHANCES OF WINNING. THE FOLLOWING PROMOTION IS VALID IN NEW JERSEY ONLY, AND IS OPEN ONLY TO QUALIFIED PERSONS (AS DEFINED IN THE RULES BELOW). DO NOT PARTICIPATE IN THE CONTEST IF YOU DO NOT FALL WITHIN THE ELIGIBILITY REQUIREMENTS AS SET FORTH BELOW. VOID ELSEWHERE AND WHEREVER PROHIBITED.

Contest Dates: Contest registration is scheduled to begin on **9/4/09 and end 12/18/09** (the “Registration Period”). The grand prize contest is scheduled to occur during each designated 2009 Regular Season Professional Football ‘Home Game’ as listed below beginning on **9/20/09 and ending on 12/20/09**. The Contest is subject to all applicable federal, state and local laws and regulations and is void where prohibited.

Who May Enter: Contest is open to legal residents of New Jersey, who are age 18 or older as of date of entry, and have a valid driver’s license, except the following classes of persons who are not eligible to enter:

- (a) Employees, officers, and directors of **Global Home Improvements, Dr. Wasserman** (collectively “Sponsor”), **WKXW-FM** (“Administrator”), Millennium Radio Group New Jersey, Million Dollar Media, LLC, each of their respective franchisees, parents, affiliated companies, subsidiaries, distributors, retailers, printers, advertising and promotion agencies, and any and all other companies associated with the design or execution of this promotion (collectively, “Released Parties”), and the members of the immediate families or households, whether or not related, of any of the above. “Immediate family members” includes, for purposes of this promotion, parents (including in-laws), grandparents, siblings (including step-siblings), children (including step-children), grand children (including step grand children) and each of their respective spouses.
- (b) Any individual who does not have current access to an internet connection to submit an on-line entry.

How to Enter – Weekly: To enter online, visit nj1015.com during the “Registration Period” and click the contest link to connect to the contest registration page. Weekly registration will close at approximately 12:00p noon on the Friday prior to each designated home game, at which time registration will begin for the next scheduled game date through the close of the Registration Period.

Each entrant must fully complete the registration page with all required information including his/her name, complete address (*including city, state and zip*), valid email address, birth date, phone number (*including area code*) – and their halftime and final score prediction for both teams playing in the next designated home game. After having read and agreed to these Official Rules, click the submit button to submit your on-line entry. All on-line entries must be fully complete for all required information.

Maximum of one entry per person or per valid email address per game date. Contestants must re-enter each week to be qualified for each weekly drawing (see below). Any on-line entry submitted with an invalid email address will be disqualified. Each participant must submit an entry on their own behalf. No person may enter more than the stated number of times as outline above in each registration method and no person may enter on behalf of another individual, or in another person’s name. Any person found in violation of this provision will be disqualified and all entries submitted by that person will be ruled ineligible for any prize award.

Sponsor and their respective subsidiaries and affiliates are not responsible for lost, late, incomplete, stolen, misdirected, illegible entries; for any entry not submitted in a manner as required by these contest rules, or not received due to any technical error or failure, unauthorized human intervention, inaccurate capture or mis-entry of any required information, or the failure to capture any such information or effects of hackers or failure of any electronic equipment, computer transmissions and/or network connections.

In the event of a dispute as to any registration or play, the authorized account holder of the e-mail address used to register will be deemed to be the registrant or player. The “authorized account holder” is the natural person assigned an e-mail address by an Internet access provider, online service provider or other organization responsible for assigning e-mail addresses for the domain associated with the submitted address. All entries become the property of the Sponsor and will not be returned.

Finalist Selection & Notification: Following the close of each weekly registration period, a random drawing will be held on the Friday prior to each designated ‘Home Game’ during the Promotion Period from among all eligible entries received for that game date, to select the one (1) official finalist for that corresponding game. The selected weekly finalist may be announced on air, and/or notified of their selection as the weekly finalist. Any selected finalist who does not meet the eligibility requirements, does not wish to participate in the grand prize contest will be disqualified. An alternate finalist will be randomly selected per the procedures outlined above, time permitting. Decisions of judges in the selection and determination of the official finalist, and all matters related to this contest are final.

IMPORTANT: Only the one (1) weekly finalist randomly selected for each game date will be eligible to participate in the grand prize contest for the chance to win the grand prize (described below). All other entrants are ineligible to participate or win, regardless of the accuracy of their prediction. Finalist selection and participation is non-transferable.

Grand Prize Contest – Score Prediction: In order for the grand prize to be awarded to an eligible weekly selected finalist, that finalist's submitted **Halftime & Final Score prediction** must exactly match the **actual Halftime & Final Score** for both teams in the designated game for which they were selected, according to the following requirements:

- **Only the one (1) official finalist selected by sponsor for each game date is eligible to participate or win. All other entries are disqualified and will not be acknowledged, regardless of the accuracy of their prediction.**
- All Score predictions must be completely accurate and match the exact score with the correct team.
 - For example, if the actual final score of a designated game is New England – 27, New York – 10, then a predicted final score of New England - 10, New York - 27 or a prediction of 27-10 without specifying the associated teams will not constitute a winning entry.
- All entries must be complete, and have been legibly received during the on-line entry process. Any incomplete, unintelligible or illegible entries will be disqualified and will not be eligible for any prize.
- The corresponding prize level (see below) will only be awarded to an eligible selected finalist if their corresponding score prediction exactly matches the actual score of the designated game for both teams.

Prize Awards & Delivery: In the event of a successful score prediction, the designated selected finalist who submitted the winning prediction will be eligible to claim the associated prize level, subject to verification of compliance with these official rules. The available prize awards are as follows:

- **Correct Halftime & Final Score Prediction for both teams:** \$100,000 Home Improvement project from Global Home Improvement. The grand prize, if awarded, will be awarded as a \$100,000 credit with Global Home Improvement. Maximum value of grand prize and home improvement project not to exceed \$100,000. Any costs related to a Home Improvement project in excess of the stated prize value are the sole responsibility of the winner. If the completed project has a retail value of less than \$100,000, the grand prize winner will not be awarded the difference between their actual project and the \$100,000 maximum prize value.
- **Correct Final Score Only Prediction for both teams:** A \$10,000 credit with Dr. Barry Wasserman towards up to two (2) LASIK procedures. Administrator reserves the right to award the cash value of the grand prize to any winner, in its sole discretion. Prize winner, if any, must sign all release forms prior to any procedures, and must release sponsors and all released parties from any and all liabilities related to such procedures prior to prize award.
- **Correct Halftime Score Only Prediction for both teams:** \$1,000 Cash prize.

All prize awards are non-cumulative. Prize awards, if any, will be awarded as credits with the designated sponsor, or as otherwise specified by Sponsor. Home improvement project must be selected from among the designated products and services available and provided by sponsor. Prizes are non-transferable and no cash redemption or prize substitution allowed, except at sponsor's sole discretion or as provided herein.

A maximum of **(1)** grand prize will be awarded in the contest, to the first official finalist who successfully completes the contest requirements according to these official rules. The contest will be concluded following the first successful halftime & final score prediction. A maximum of **(2)** final score only and **(2)** halftime score only bonus prizes will be awarded. If the prize winning requirements are not successfully completed by an eligible contestant during the contest period for any prize level, then the corresponding prize level **will not be awarded**.

Prize winner(s), if any, must accept delivery of prize from sponsor, or as otherwise instructed by sponsor. All other costs related to prize delivery and acceptance is the responsibility of winner including but not limited to all applicable taxes. All properly claimed prizes will be awarded. Sponsor reserves the right to substitute a prize of equal or greater value if an advertised prize becomes unavailable.

Grand prize winner(s) will be required to complete and return a W-9 form (*if prize value exceeds \$600.00*), affidavit of eligibility, and liability/publicity release (*Tennessee residents need not sign publicity release*), and present a valid driver's license and social security card before prize will be awarded. Winners of prizes greater than \$600.00 will be issued a 1099 form reflecting the value

of the prize(s) and are responsible for paying all income taxes on prize(s). Failure to collect or properly claim any prize in accordance with these rules will result in forfeiture of the prize. If forfeited for any reason, contestant will not receive any other prize substitution or compensation. Total ARV of all available prizes: **\$111,000**.

Additional Rules & Restrictions: By participating in this contest, entrants agree to abide by and be bound by the Official Rules and the decisions of the Administrator, which shall be final in all matters relating to this contest. In the event an entrant wins a prize, and is later found to be in violation of these rules he/she will be required to forfeit the prize or to reimburse Sponsor for the stated value of the prize if such violation is discovered after winner has used the prize. Participation in contest constitutes permission for the Sponsor and its agencies to use winners' names and/or likenesses for purposes of advertising and trade in any media worldwide without limitation or further compensation unless prohibited by law. By accepting prizes, winners agree to hold sponsor, and released parties (collectively "Releasees"), from any claims, losses, actions, or damages of any kind, whether actual, incidental or consequential, for injury (including but not limited to death), damages, losses or expenses arising out of or relating to entrant's participation in this contest, or the acceptance, possession or use/misuse of any prize, or participation in prize-related activities (including but not limited to travel related thereto), and to assume all liability in connection therewith.

Releasees shall not be liable to any winner, entrant or any other person for failure to supply the prize or any part thereof by reason of any acts of God, any actions, regulations, orders, or requests by any governmental entity, equipment failure, terrorist acts, war, fire, unusually severe weather, embargo, labor dispute or strike, labor or material shortage, transportation interruption of any kind, or any other cause beyond Releasees' sole control. IN CASE OF DISPUTES: By participating, each entrant agrees that (1) any and all disputes, claims, and causes of action arising out of or in connection with this Promotion, or any prizes awarded, shall be resolved individually, without resort to any form of class action, and any judicial proceeding shall take place in a federal or state court within the State of New Jersey; (2) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Promotion, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental, and consequential damages, and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
