

\$1,000,000 Bracket Prediction Challenge

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT IMPROVE CHANCES OF WINNING. THE FOLLOWING CONTEST IS VALID IN THE U.S. ONLY, AND IS OPEN ONLY TO QUALIFIED PERSONS (AS DEFINED IN THE RULES BELOW). VOID ELSEWHERE AND WHEREVER PROHIBITED. DO NOT PARTICIPATE IN THE CONTEST IF YOU DO NOT FALL WITHIN THE ELIGIBILITY REQUIREMENTS AS SET FORTH BELOW.

Contest Name: \$1,000,000 Bracket Prediction Challenge (the “Contest”).

Contest Dates: Contest registration is scheduled to begin on **3/2/11** and is scheduled to **end at 11:00am EST on 3/17/11** (the “Registration Period”). The Grand Prize Contest is scheduled to occur between 3/17/11 – 4/4/2011 during the designated 2011 Men’s College Basketball Tournament. Contest is subject to all applicable federal, state and local laws and regulations and is void outside the U.S. and where prohibited.

Designated Tournament: 2011 Men’s College Basketball Tournament being played between 3/17/2011 – 4/4/2011, with the Semi-Final & Championship games to be held in Houston, TX.

Who May Enter: Contest is open to legal residents of Pennsylvania and New Jersey, who are **age 18 or older** as of date of entry, and have a valid U.S. drivers license except the following persons who are not eligible to enter or win:

- (a) Employees, officers, and directors of **Mountain Dew and Franks Red Hot** (collectively “Sponsors”), **Clear Channel** (“Station”), **Million Dollar Media, LLC** (the “Administrator”), other participating Sponsors, each of their respective franchisees, parents, affiliated companies, subsidiaries, distributors, retailers, printers, advertising and promotion agencies, and any and all other companies associated with the design or execution of this promotion (collectively, “Released Parties”), and the members of the immediate families or households, whether or not related, of any of the above. “Immediate family members” includes, for purposes of this promotion, parents (including in-laws), grandparents, siblings (including step-siblings), children (including step-children), grand children (including step grand children) and each of their respective spouses, regardless of where they reside.
- (b) Individuals who do not have access to an internet connection in order to visit the contest website, or a valid email address to register.

How to Enter – On-Line Registration: Visit www.wdasfm.com, www.q102.com, www.my1061.com, www.radio1045.com, www.rumba1480.com, www.power99.com, during the “Registration Period” to connect to the Contest registration page. Fully complete the on-line registration with all required information, including your name, complete address (*including city, state and zip*), valid email address, birth date, phone number (*including area code*) and favorite Clear Channel Philadelphia station using the drop down list. Each registrant will designate their own “Screen Name”, and must enter their username (email address) and password. The designated “Screen Name” will be displayed on the “Standings Page” during the contest. Each registrant’s username (email address) & password will allow participants to return to the contest site to Log-in and view their prediction, points and standings.

After having read and agreed to these Official Rules, click the submit button to submit your on-line registration. All entries must be fully complete for all required registration information. Any entry submitted with an invalid email address will be disqualified. **Maximum of one entry per person or per valid email address.** Any contestant submitting more than one entry will void all entries by that contestant.

Any available opt-in opportunities are not required to enter the Contest, and checking the opt-in boxes will not improve your chances of winning. By participating and submitting an entry, contestant agrees that sponsors and participating parties are authorized to contact entrant via email, mail, phone or any other form of media to make contestant aware of information pertinent to the contest, and to distribute information regarding the Sponsor(s) featured products, special events or promotional offers, or purchase incentives. Contestants may opt-out of any further email communication at any time by simply replying REMOVE to any email message, or following the provided opt-out instructions.

Bracket Prediction – Must be completed and submitted by 11:00am ET on 3/17/2011:

Bracket predictions must be completed and submitted between:

- 3/13/2011 – Following team selection announcements for the designated Men’s College Basketball Tournament**
- 3/17/2011 – Prior to 11:00am ET**

Bracket: Once the designated 2011 Men’s College Basketball Tournament team selections have been announced on 3/13/11 – all registered or newly registering participants must fully complete the provided Bracket Prediction form on the Edit/Update Picks page of

the contest website.

Tie-Breaker: Each participant will also be required to submit their prediction of the **Total Cumulative Points** to be scored in the Championship Game on 4/4/11. Any contestant who failed to complete the Total Cumulative Points “tie-breaker” prediction will be assigned a point total of 0 cumulative points for the Championship Game.

Save Picks: Participants are required to click the ‘**Save Picks**’ button on the contest website to save their bracket predictions selections, cumulative score prediction or updates to their predictions. Any changes or predictions made without clicking the “Save Picks” will not be saved or recognized for this contest.

Completed bracket prediction entries must be **received by 11:00am ET on 3/17/2011** in order to be eligible to participate or claim any prize. Any registered participant or contestant who fails to fully or correctly complete the on-line registration form, or fully and correctly complete the required Bracket Prediction for all (63) games in the designated tournament (and Save their picks) will be disqualified from the contest and will be ineligible to claim any prize (*see below*). Any bracket prediction not received by the required deadline for any reason including, but not limited to transmission error, internet problems, equipment or website malfunction, internet traffic or errors caused by viruses or hackers will be disqualified. Sponsor is not responsible for any delays or difficulty in receipt an eligible contestant’s Bracket Prediction that prevents participation.

Any incomplete or illegible entries will be disqualified. Released Parties are not responsible for lost, late, misdirected, illegible, incomplete, invalid, unintelligible, damaged, or for entries submitted in a manner that is not expressly allowed under these rules, or for any entry not submitted or received due to any technical error or failure, unauthorized human intervention, inaccurate capture or mis-entry of any required information, or the failure to capture any such information or effects of hackers or failure of any electronic equipment, computer or cellular transmissions and/or network connections; all of which will be disqualified.

Each participant must submit an entry on his/her own behalf. Any entry submitted on behalf of another individual or using another person’s email address or name will be disqualified and ineligible to claim any prize. No mechanically reproduced or automated entries permitted. Use of any automated system to participate is prohibited and will result in disqualification and all such entries will be deemed void.

In the event of a dispute as to any on-line registration, the authorized account holder of the e-mail address used to register will be deemed to be the registrant and he/she must be eligible according to these Official Rules. The “authorized email account holder” is the natural person assigned an e-mail address by an Internet access provider, online service provider or other organization responsible for assigning e-mail addresses for the domain associated with the submitted address. All entries received become the property of the Sponsor and will not be returned.

Scoring – Bracket Points: Each eligible participant who has successfully completed the on-line registration and bracket prediction as required by these Official Rules will receive the following points for each of the (63) games for which they have correctly predicted the winning team:

- 1 point for each correct pick in Round 1
- 2 points for each correct pick in Round 2
- 3 points for each correct pick in Round 3
- 4 points for each correct pick in Round 4
- 5 points for each correct pick in Round 5
- 6 points for the correct Champion

Any incorrect predictions will receive 0 points. The maximum point total for correctly predicting the winning team in every game played during the designated Men’s College Basketball Tournament is 120 points. At the completion of the designated tournament, each eligible contestant bracket prediction received will be compared to the actual bracket outcome.

Tie Breaking Procedures – Bracket Winner: In the event of a tie among any point leaders in the Bracket prediction, the tie-breakers to determine the „Bracket Winner” for the 1st place prize package shall be as follows:

1. Contestant who has predicted closest to the actual Cumulative Points total in the Championship game, regardless if the prediction is higher or lower than the actual point total.
2. In the event of a remaining tie among any eligible contestants, the tie-breaker shall then be a random drawing conducted by the Contest Administrator.

In order for the grand prize to be awarded, an eligible contestant must correctly predict all (63) games in the designated Men’s College Basketball Tournament. **If no eligible contestant correctly predicts all 63 games, then the Grand Prize will not be awarded.**

In order for the bonus prize to be awarded, an eligible contestant must correctly predict (60) or more games in the designated Men's College Basketball Tournament. If no eligible contestant correctly predicts 60 or more games, then the **Bonus Prize will not be awarded.**

Prize Awards: The following prize awards will be available to eligible contestants participating in the Contest:

Grand Prize – Predict all (63) Games Correctly (“Perfect Bracket”): If an eligible contestant correctly predicts all (63) games in the designated Men's College Basketball Tournament, they will be eligible to claim the grand prize subject to verification of compliance with these official rules. The grand prize is: **\$1,000,000 40 yr. Annuity. If awarded, grand prize will be payable in (40) equal annual installments of \$25,000 Cash, without interest, on or about the anniversary date of the winning attempt.** The first installment will be awarded approximately 2 to 4 weeks following verification and approval of all required contest information.

A maximum of one (1) grand prize will be awarded. In the event of multiple winning entries, then the cash value of the grand prize will be evenly distributed among eligible winning contestants. **If no eligible contestant successfully completes the grand prize winning requirements, then the grand prize will not be awarded.**

Bonus Prize – Predict (60) or more Games Correctly: If an eligible contestant correctly predicts (60) or more games in the designated Men's College Basketball Tournament, they will be eligible to claim the bonus prize subject to verification of compliance with these official rules. The bonus prize is: **\$10,000 Cash.**

A maximum of one (1) bonus prize will be awarded. In the event of multiple winning attempts, then the cash value of the bonus prize will be evenly split among eligible winning contestants. If no eligible contestant successfully completes the bonus prize winning requirements, then the bonus prize **will not be awarded.**

1st Place Prize – Most Correct Games (“Bracket Winner”): The eligible contestant who predicts the most games correctly, thereby earning the most points in the bracket challenge, will be eligible to claim the 1st Place Prize subject to verification of compliance with these official rules. The 1st Place prize is: (1) Home Theatre System with HD LCD TV with Xbox 360 consoles with a maximum retail value of \$2,350.00

A maximum of one (1) 1st Place prize will be awarded. In the event of multiple contestants being tied for the most games predicted correctly, then the tie breaking procedures (*see above*) will apply for determining the 1st Place winner.

2nd Place Prize – 2nd Most Correct Games (“Bracket Runner-up”): The eligible contestant who predicts the 2nd most games correctly, thereby earning the 2nd most points in the bracket challenge, will be eligible to claim the 2nd Place Prize subject to verification of compliance with these official rules. The 2nd Place prize is: (1) Scooter with a maximum retail value of \$1,000.00

A maximum of one (1) 2nd Place prize will be awarded. In the event of multiple contestants being tied for the most games predicted correctly, then the tie breaking procedures (*see above*) will apply for determining the 2nd Place winner.

Prize winners must accept delivery of prize from sponsor, or as otherwise instructed by sponsor. All other costs related to prize delivery and acceptance are the responsibility of winner including but not limited to taxes, title, insurance, license, and registration fees.
