

Mrs. Claus Clocks Christmas How to Win / Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. Sweepstakes is open only to legal Maryland residents, 18 years or older and residing in Maryland at the time of entry. THIS SWEEPSTAKES IS VOID WHERE PROHIBITED AND OUTSIDE MARYLAND

1. Sweepstakes Name: Mrs. Claus Clocks Christmas (the "Sweepstakes")

2. Sweepstakes Dates/Registration Period: The Sweepstakes is scheduled to begin 12/3/08 at 12:00 EST and end 1/19/09 at 11:59 EST (the "Registration Period"). Sponsors' clock shall be the official time piece of the Sweepstakes.

The Baltimore Sun and K Bank Broadway Across America ("Sponsors"), their subsidiaries and affiliated companies, will conduct the Sweepstakes substantially as described in these rules, and by participating, each participant agrees as follows:

3. How to Enter – Online Registration

Puzzle Entry: To enter, visit www.baltimoresun.com or www.metromix.com during the Registration Period and click the Sweepstakes link. Each entrant will be given (9) multiple choice puzzlers to answer. In order to complete the game and advance to the Sweepstakes registration page, an entrant must solve 6 of 9 puzzles. Any entrant who does not correctly solve at least (6) puzzles will be disqualified and will not have an opportunity to advance to the Sweepstakes registration page during that attempt unless the entrant accesses the registration page via the alternate entry method discussed below. Entrants may continue to attempt the Sweepstakes until they are able to advance to the Sweepstakes registration page. Any entrant who advances to the Sweepstakes registration page will be required to enter their name, address, birth date, phone number, valid email address and answer the Sponsors' survey question. **Alternate Entry:** To register for the Sweepstakes without playing the puzzle game, simply click the following link which will direct you to the Sweepstakes registration page: <http://www.mdmgames.com/mrsclausBaltimoreSun/register.aspx>

Instant Win Game: Upon completing the registration, the entrant will be asked to click on 1 of 4 icons to determine if they are the winner of an "Instant Win Prize". Ten (10) computer-generated instant-winning times will be randomly generated during the Promotion Period. If you are the first player to play the Instant Win Game at or after one of the randomly generated times, you will be a potential instant winner of the prize indicated. If you receive a "winner" message, please print it and save it for your records. After the completion of the Sweepstakes, Sweepstakes Administrator will send the Instant Win Prize certificate to contact information provided on the registration form.

Maximum of one completed Sweepstakes registration per person or per valid email address during the Sweepstakes period. Each participant must submit an entry on their own behalf. Any entry submitted by a contestant on behalf of another individual or using another person's email address or name will be disqualified and ineligible to claim any prize. All eligible contestants must register using a valid email address. Any entry submitted with an invalid email address will be disqualified.

Any attempt by any participant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods void that participant's entries and that participant may be disqualified. No mechanically reproduced or automated entries permitted. Use of any automated system to participate is prohibited and will result in disqualification. Sponsors and their subsidiaries and affiliates are not responsible for lost, late, incomplete, invalid, unintelligible or misdirected registrations or for any entry not submitted or received due to any technical error or failure, unauthorized human intervention, inaccurate capture or mis-entry of any required information, or the failure to capture any such information or effects of hackers or failure of any electronic equipment, computer transmissions and/or network connections, which will be disqualified.

All eligible entries must be submitted and received by during the Registration Period. Any entry submitted after the close of the Registration Period, or any entry not received by the close of the Registration Period for any reason will be disqualified. In the event of a dispute as to any registration or play, the authorized account holder of the e-mail address used to register will be deemed to be the registrant or player. The "authorized account holder" is the natural person assigned an e-mail address by an Internet access provider, online service provider or other organization responsible for assigning e-mail addresses for the domain associated with the submitted address. All received entries become the property of the Sponsors and will not be returned.

4. Winner Selection & Notification: On or about **1/20/09**, a random drawing will be held from among all eligible entries received from all entry methods combined to select a total of one (1) potential Grand Prize winner (*see Grand Prize description below*) and one (1) potential runner-up prize winner (*see Runner-Up Prize description below*). Odds of being selected as the Grand Prize winner are dependent upon the total number of eligible entries received from all entry methods combined. Decisions of the Administrator in the selection and determination of Grand Prize winner and, all matters relating to this Sweepstakes, are final and binding.

The potential Grand Prize and Runner-Up prize winner will be notified initially by phone beginning on or about **1/6/09**. If the Administrator is unsuccessful in its attempts to reach and speak directly with the potential Grand Prize winner by phone after three attempts over a 72-hour period to the phone number listed on that entrant's entry, then that entrant will be disqualified and, at Administrator's discretion, an alternate potential Grand Prize winner will be randomly selected from among the remaining eligible entries and notified as per the procedures outlined above (time permitting).

5. Prize(s).

One (1) Grand Prize winner will be awarded a pair of tickets to opening night to four (4) Broadway Shows at the Hippodrome Theatre. Approximate Retail Value ("ARV"): \$520. One (1) Runner-Up prize winner will be awarded a pair of tickets to opening night to one (1) Broadway Show at the Hippodrome Theatre. ARV: \$140. Ten (10) Instant Prize winners will be awarded a pair of tickets to opening night to one (1) Broadway Show at the Hippodrome Theatre. ARV: \$140 each. Broadway Show will be solely determined by Sponsor and subject to availability. Total ARV of all available prizes: \$2,060

Winners must accept delivery of prize from Sponsors, or as otherwise instructed by Sponsors. All other costs related to prize delivery and acceptance is the responsibility of winner. Baltimore Sun, K Bank Broadway Across America ("Sponsors"), and Million Dollar Media, LLC ("Sweepstakes Administrator"), participating third-party sponsors/advertisers, and each of their respective franchisees, parents, affiliated companies, subsidiaries, distributors, retailers, printers, advertising and promotion agencies, and any and all other companies associated with the design or execution of this Sweepstakes (collectively, "Released Parties"), and the members of the immediate families or households, whether or not related, of any of the above are not eligible. The Sponsors disclaim any liability for entries not received due to technical difficulties or transmission errors. The Sponsors disclaim all liability for any delays, mis-delivery, loss, or failure in the delivery of any item sent by electronic transmission, or other delivery method. Released Parties are not responsible for mechanical, technical, electronic, communications, telephone, computer, hardware or software errors, malfunctions or failures of any kind, including: failed, incomplete, garbled or delayed transmission of online entries, traffic congestion on telephone lines, the Internet or at any website or lost or unavailable network connections which may limit an online entrant's ability to participate in the Sweepstakes, and any injury or damage to entrant's or any other person's computer or mobile phone related to or resulting from participating in or downloading any information necessary to participate in the Sweepstakes. Released Parties are not responsible for any other errors of any kind, whether computer, technical, typographical, printing, human or otherwise, relating to or in connection with the Sweepstakes, including, without limitations, errors which may occur in connection with the printing or advertising of this

If Sponsors do so, Sponsors shall post notice on the Sweepstakes website. In the event of early termination of the Sweepstakes, Sponsors will award remaining Instant Win Prizes and determine the Grand Prize Finalist in a random drawing from among all eligible, non-suspect entries received as of the time/date of such termination.

8. IN CASE OF DISPUTES:

By participating, each entrant agrees that (1) any and all disputes, claims, and causes of action arising out of or in connection with this Sweepstakes, or any prizes awarded, shall be resolved individually, without resort to any form of class action; (2) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Promotion, and in no event will entrant be entitled to received attorneys' fees or other legal costs; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental, and consequential damages, and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
