

LA28 Brand Anniversary Sweepstakes Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE DOES NOT IMPROVE CHANCES OF WINNING. Sweepstakes Name: LA28 Brand Anniversary Sweepstakes (the "Sweepstakes").

Sweepstakes Dates: Sweepstakes registration begins at 12:00:00am Eastern Time ("ET") on **11/6/2021** and ends at 11:59:59pm ET on **11/20/2021** or whenever all instant win prizes have been awarded, whichever occurs first (the "Registration Period" or "Sweepstakes Period"). The Sweepstakes grand prize drawing shall occur on or about **11/22/2021** as outlined below. The Sweepstakes is subject to all applicable federal, state and local laws and regulations and is void outside of the U.S., and wherever prohibited or restricted by law.

Who may Enter: Sweepstakes is open only to legal residents of the 50 United States and District of Columbia, who are age 18 or older as of date of entry, and have a valid driver's license or government issued photo ID, except the following persons who are not eligible to enter or win:

How to Enter – Internet Entry: To enter, visit www.LA28Sweepstakes.com during the Registration Period. Each entrant must fully complete the online registration page with all required information including name, complete address (including city, state and zip code), valid email address, birth date, and phone number (including area code). After having read and agreed to these Official Rules, click the submit button to submit your online entry. All online entries must be fully complete with all required information, and must be received by **11:59:59p ET on 11/20/2021** to be eligible. Any online entry submitted with an invalid email address will be disqualified.

Limit of one entry per person and per valid email address during the entire Registration Period, but once registered eligible entrants may participate in the instant win trivia game up to one time per day during the remainder of the Sweepstakes Period (see below). Your registered email address may be used to login for each return visit to participate in any daily instant win game.

Released Parties are not responsible for lost, late, misdirected, incorrect, illegible, incomplete, invalid, unintelligible, or damaged entries, or for entries submitted in a manner that is not expressly allowed under these Official Rules, or for any entry not submitted or received due to any technical error or failure, human error, unauthorized human intervention, inaccurate capture or mis-entry of any required information, failures, omissions, interruptions, deletions, or defects of any cell phone provider, network computer online systems, computer equipment, servers, or software, including any injury or damage to participant's or any other person's computer relating to or resulting from participation in this Sweepstakes; or the failure to capture any such information or effects of hackers or failure of any electronic equipment, computer or cellular transmissions and/or network connections; all of which will be disqualified.

Any available opt-in opportunities are not required to enter the Sweepstakes or to be eligible to win a prize, and opting-in will not improve your chances of winning. How to Play – Instant Win Trivia Game (*daily instant win prize awards*): After completing the online registration page (first time visitors) or logging in with your registered email address (for return visitors), click the link to the 'Instant Win' trivia game play page. The trivia game play page will then display a random trivia question. To determine if you are an instant prize winner, click on an answer to the daily trivia question.

- **Note: You are not required to answer the trivia question correctly, in order for a chance to be determined as a potential instant win prize winner.**

Eligible participants have the opportunity to answer an available trivia question once per day, each day during the entire Sweepstakes period. Sizes and color as solely determined and designated by Sponsor, based upon availability. Sponsor reserves the right to substitute an alternate merchandise item of approximate equal or great value, at its sole discretion, based upon availability. Total ARV of grand prize: \$420.95.

General Prize Conditions:
